Honesty, compliance with legislations, prevention of corruption

At UAB PLAMIKA we distance ourselves from and strongly condemn corruption, bribery and other acts or activities contrary to the Constitution, laws, other legal acts, court decisions, instructions of state and municipal institutions and bodies of the Republic of Lithuania and the provisions of this code.

Ethical competition and business solidarity

Human rights and Child Labour

Our company unequivocally supports the defence and protection of human rights, follows European Convention of Human Rights and all the principles mentioned in it: human rights must be respected; discrimination based on racial traits, gender, nationality, language, religious beliefs, financial or social status, etc., child labour is prohibited; the right to privacy is recognized; the right to fair remuneration for work, statutory working hours and working conditions is recognized.
